

Accessibility Audit Report – Padel UNO Platform

Audit Date: June 04, 2025

Methodology: Combined automated and manual testing (Axe, Lighthouse, WAVE, screen reader, keyboard navigation)

Summary

This report outlines the accessibility issues identified on the Padel UNO web platform based on testing conducted on June 04, 2025. The audit was carried out using both automated tools and manual review techniques. The current state of the platform is **non-compliant** with WCAG 2.2 Level AA. The issues listed below are grouped by WCAG criteria and indicate the severity level for each.

Error messages are missing or unclear when form submission fails, preventing users from understanding what needs to be corrected	3.3.1, 3.3.3	Critical
Possible browser incompatibilities due to parsing errors	4.1.1	Minor

Notes

- **Critical:** Prevents users with disabilities from completing key tasks.
- **Major:** Significantly impairs usability or understanding.
- **Minor:** Low impact but should be corrected.
